Engineer:

- Small water grant has been submitted however awarding of grant funding will not occur until November.

- Hydrant flushing report was distributed to the board
 - Fire hydrant near 762 Lincoln Avenue was leaking.
- PennDOT repaired the collapsed section of the drain on Fireline Road, near the old Fireline Hotel.

Property/Water Operations:

- Water service line was replaced at 671 E. Mill Street on 4/18/2025.
- Water service line was replaced at 756 Lime Street on 5/8/2025
- GSI Mapping quote was received from PA Rural of \$10,250.00; this does not include labor time to mark out all water lines/curb stops/etc.
- Joe Liberti will check the status of Well #1
- Tank inspection will be done over the summer
- Shane, Owner of Tri valley Water Hauling, reported on May 8th, that he noticed tire tracks in the neighbor's yard and was advising it was not done by his water hauling trucks.
- **A motion was made by Joseph Civitella, 2nd Chad Everett to replenish water parts from L/B Water, but not to exceed \$10,000, Motion carried.**
